5. The Grant must be drawn monthly on or before 31st March, 1978 & no claim for lapsed grant will be entertained at any cost.

A statement is enclosed herewith showing the number of posts sanctioned against each college with the existing incumbents. The incumbents shown in the statement are provisionally allowed to continue subject to verification of relevant records. The incumbents shown in the statement are entitled to minimum of the admissible scale of pay and allowances.

The sanction is also subject the following conditions:

1. Necessary approval for each incumbent should be obtained from the D.P.I. after furnishing all supporting documents.
2. All future appointments are to be made in accordance with the departmental rules and with prior approval of the D.P.I.
3. The persons holding the post of Principal will remain as Principal in-charge and will draw lecturers' scale of pay plus Rs. 100/- p.m. as Charge Allowance till he is selected by the State Selection Board and his appointment is regularised by the Deptt. in due course.
4. All Lecturers must appear before the State Selection Board for their selection in due course for regularisation. If any one is not recommended by the State Selection Board, his/her service will be terminable by the Governing Body of the college.
5. The college authority should strictly follow the departmental rules in the matter of management and appointment and maintenance of employees.
6. The Secretary of the respective Governing Body will draw the grants for the period from 1.9.83 to 29.2.84 on or before 31st March, 1984 with countersignature of the bill by the D.P.I., Assam.

The excess amount, if any, may be refunded to the local treasury with an intimation to this office.

In inviting a reference to the subject cited above,
I have the honour to state that Govt. have been pleased to take
over the **Duliajna** College, P.O. **Duliajna**
Dist. **Dibrugarh** under deficit system of G.I.A.
w.e.f. 25.3.98 vide Govt. Notification No. B(2)H. 553/96/85, dtd.
21.8.98 and Govt. letter No. B(2)H. 553/96/86, dtd. 17.9.98. The
appointment of incumbents holding the post of lecturers in the
defferent Departments fulfilling the present U.G.C. norms for
appointment as lecturers as per Govt. of India's letter No.
F.1-21/87/UI, dtd. 17.6.87 their letter of even No. dtd. 22.7.88,
Govt. of Assam in the Education Department's letter No. EPG.559/
87/Pt.-III/87-A, dtd. 15.12.88, No. 559/87/223, dtd. 6.8.89 and
EPG.559/87/Pt.-III/187, dtd. 6.3.90 as shown in the statement
enclosed are hereby provisionally approved w.e.f. 25.3.98 or
there after, as the case may be, against the posts sanctioned vide
Govt. letter No. B(2)H. 553/96/86, dtd. 17.9.98.

As such the appointment of the incumbents holding
the posts of non-teaching staff as shown in the statement enclosed
are also provisionally approved w.e.f. 25.3.98 or thereafter, as
the case may be. They are also entitled to draw the minimum of
the time scale of pay and other allowances as admissible under
the rules w.e.f. 25.3.98 or from the date of approval of their
appointment which-ever is later.

In the aforesaid statement some posts have been shown as vacant as the posts are either actually vacant or the incumbents holding the posts do not possess to present UGC norms. Vacant posts may be filled up after observing all formalities as per UGC guide lines and Departmental procedure & norms. As regards Department's Headship allowances necessary proposal for this purpose with specific resolution of the G.B. including the Head of the Deptt. should be furnished to the D.H.I., Assam for sanction of Headship allowances. In determining the Head of the Deptt., seniority in service be strictly followed. The deptt's having affiliation upto B.A. part-II level of GU/DU with prior concurrence of the Govt. will be admissible for Head ship allowance, if there are more than one approved teachers posts sanctioned for the subjects which are common to both Arts, Science and Commerce streams as the case may be.


All the lecturers must fulfill the required conditions as laid down by the UGC for obtaining next Higher scale under UGC scheme in due time, other-wise they will be not allowed the above mentioned higher scale during their service period.

It may be noted here that the approval of appointments is hereby provissional. As such necessary proposal for formal approval of appointment of all teaching and non-teaching staff as shown in the aforesaid statement should everiable be submitted to this Directorate at the earliest alongwith the undermentio^{ed} documents.
